一、培养目标 Objectives

二、毕业要求 Graduation Requirements

本专业要求学生系统掌握法学的基本理论和基础知识，受到法律思维和法律实务的基本训练，能理论联系实际，具有运用法学理论及方法分析、解决实际问题的能力。毕业生应获得以下几方面的知识和能力：

- 1、掌握国内现行法律的知识；
- 2、具备从事法律实务的职业技能，能应用法学理论和法律规则解决法律纠纷；
- 4、具有良好的口头、书面表达能力和和逻辑思维能力；
- 5、掌握文献检索、资料查询的基本方法；
- 6、具备外语听说读写能力。

This major requires students to systematically master the basic theories and basic knowledge of law, receive basic training in legal thinking and legal practice, be able to integrate theory with practice, and have the ability to use legal theories and methods to

analyze and solve practical problems. Graduates should acquire knowledge and competencies in the following areas:

1. Master the knowledge of current domestic laws ;
2. Have professional skills to engage in legal practice, and be able to apply legal theories and legal rules to resolve legal disputes;
4. Good oral and written expression skills and logical thinking skills;
5. Master the basic methods of literature retrieval and data query;
6. Have foreign language listening, speaking, reading and writing skills.
